Reported that the lagoons are needing a new pump, waiting to hear back on a price and maintenance was done on 2 of the lagoon pumps. New blades will be needed next year for the lawn mower, have been sharpened twice already. Ditches will be sprayed closer to when it freezes

Oldham Gym – Roach asked if Oldham Community Center will be charged for sewer, after discussion, they will be charged at the normal business rate.

Delinquent bills – Motion by Roach to send #25 and #27 to the collection process. 2nd by Beekman. All approved, motion carried. Motion by Roach to forgive #82, 2nd by Bickett. All approved, motion carried.

Nuisance Properties – Roach brought two properties that need to be condemned. Much discussion was had, no action taken at this time as council is waiting to see what previous condemned properties will cost for removal.

Gazebo – Bickett suggested more of a picnic shelter option rather than gazebo, no action to be taken until next spring.

Grant application/park equipment –Options discussed for grand application, Roach suggested using some towards fixing up the bathrooms. Roach to get bids for new doors in the bathroom

Motion by Bickett to have elections in June. 2nd by Roach. All approved, motion Carried.

Building permits reviewed and discussed. Motion by Bickett to approve building permit #15. 2nd by Beekman. All approved, motion carried. Motion by Beekman to approve Building permit #16 2nd by Roach. WHEREAS, Kingsbury County received assistance in the preparation of the Kingsbury County Pre-Disaster Mitigation Plan 2024-2030 from representatives of the City of Oldham and received funding from the South Dakota Office of Emergency Management / FEMA; and

WHEREAS, several public planning meetings were held between January of 2024 and January of 2025 regarding the development and review of the Kingsbury County Pre-Disaster Mitigation Plan 2024-2030; and

WHEREAS, the Kingsbury County Pre-Disaster Mitigation Plan 2024-2030 contains several potential future projects to mitigate hazard damage in the City of Oldham and

WHEREAS, the Federal Emergency Management Agency (FEMA) has rendered its approval of the Kingsbury County Pre-Disaster Mitigation Plan on July 14, 2025; and

WHEREAS, a duly-noticed public hearing was held by the Kingsbury County Pre-Disaster Mitigation Team on January 16, 2025 to solicit public comment on the Kingsbury County Pre-Disaster Mitigation Plan 2024-2030; and

WHEREAS, a duly-noticed public meeting was held by the Oldham Town Board on October 6, 2025 to formally approve and adopt the final Kingsbury County Pre-Disaster Mitigation Plan 2024-2030.

NOW, THEREFORE BE IT RESOLVED that the Oldham Town Board adopts the Kingsbury County Pre-Disaster Mitigation Plan 2024-2030.
